Tapestry is an online reporting tool that we use to record children's acheivements here at Pippins. It helps us to track a child's development, which in turn helps us to plan their next steps. For parents, it is a wonderful insight into their child's life! Once at home, you can show your child a photo we've taken and suddenly they'll remember what happened, and tell you all about it.

## Tapestry photos

We take photographs to add to children's observations within Tapestry. Parents can then see those observations, and add their own comments. Parents can upload their own photos of their child's achievements.

Children at Pippins very rarely play on their own, and some photos will be of group work. Other children will occasionally be named, if relevant eg, "Jo and Alex shared the trains really well". Therefore, we need permission for your child's image to be included in other children's learning journals.
